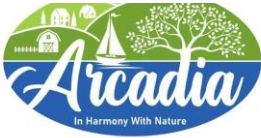

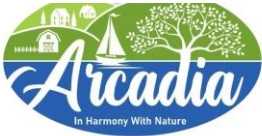
5. BIDS

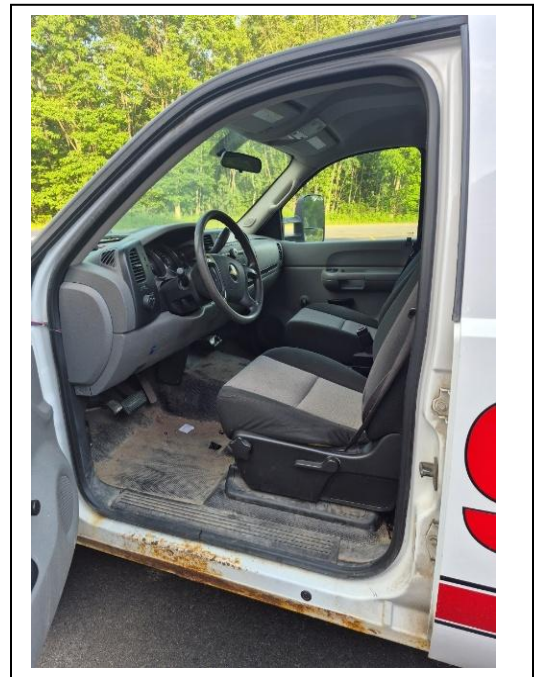


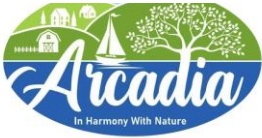
