

**VILLAGE OF CAMBRIDGE-NARROWS
BY-LAW NO. 12.1
TO STOP-UP AND CLOSE A PORTION OF NORTHRUP ROAD**

A BY-LAW OF THE MUNICIPALITY OF CAMBRIDGE-NARROWS TO STOP-UP & CLOSE A PORTION OF THE NORTHRUP ROAD

The Council of the Village of Cambridge-Narrows, under authority vested in it by Section 10 of the *Local Governance Act*, S.N.B. 2017, c.18, as follows:

This By-Law may be cited as the "Village of Cambridge-Narrows Stop-up & Closure By-Law No. 12.1.

WHEREAS it has been determined that the land hereafter described is not required for public highway uses.

BE IT ENACTED BY THE Council of the Village of Cambridge-Narrows pursuant to the authority granted under Section 10 of the *Local Governance Act*, S.N.B. 2017, c.18, of New Brunswick that the following portion of the Northrup Road be stopped up and closed permanently.

All that certain part or portion of the Northrup Road adjacent to the properties PID# 45086220 and 45202439 located in the Village of Cambridge-Narrows of Queens County.

BEING AND INTENDING TO BE all of the roadway lying parallel to PID# 45086220 and PID# 45202439 to which the transferor gained title by virtue of Order in Council 74-386, which transferred ownership from the Province of New Brunswick to the Village of Cambridge-Narrows, more particularly shown on attached Schedule "A".
