

**BY-LAW NO. 12**  
**A BY-LAW OF THE VILLAGE OF CAMBRIDGE-NARROWS**  
**TO STOP UP AND CLOSE A PORTION OF PICKETTS COVE ROAD**

The Council of the Village Cambridge-Narrows, by the authority vested in it by Section 187 of the Municipalities Act, R.S.N.B., Chap.M-22, and amendments thereto, enacts as follows:

That portion of Picketts Cove Road, in the Village of Cambridge-Narrows, in the County of Queens, bounded and described as follows:

Being the old roadway known as the Picketts Cove Road located east of the Hairpin Turn Road on lot no. 30 originally granted by the Crown to James Akerley twenty and twelve hundredths (20.12) in width extending from the grant line or western boundary of 649839 N. B. Ltd. property easterly to the shore or ordinary mean high water mark of Picketts Cove of the Washademoak Lake as shown on plan no. 192 filed in the Queens County Registry Office on March 03, 1927. The said roadway to be Stopped Up and Closed is shown on a " Plan Showing, Portion of Picketts Cove Road, to be Stopped Up and Closed, Village of Cambridge-Narrows, Parish of Johnston, Queens County, New Brunswick" prepared by Hughes Surveys & Consultants Ltd., dated November 29, 2011 attached as Schedule "A".

is hereby permanently stopped up and closed commencing on the date of the coming into force of this By-Law.

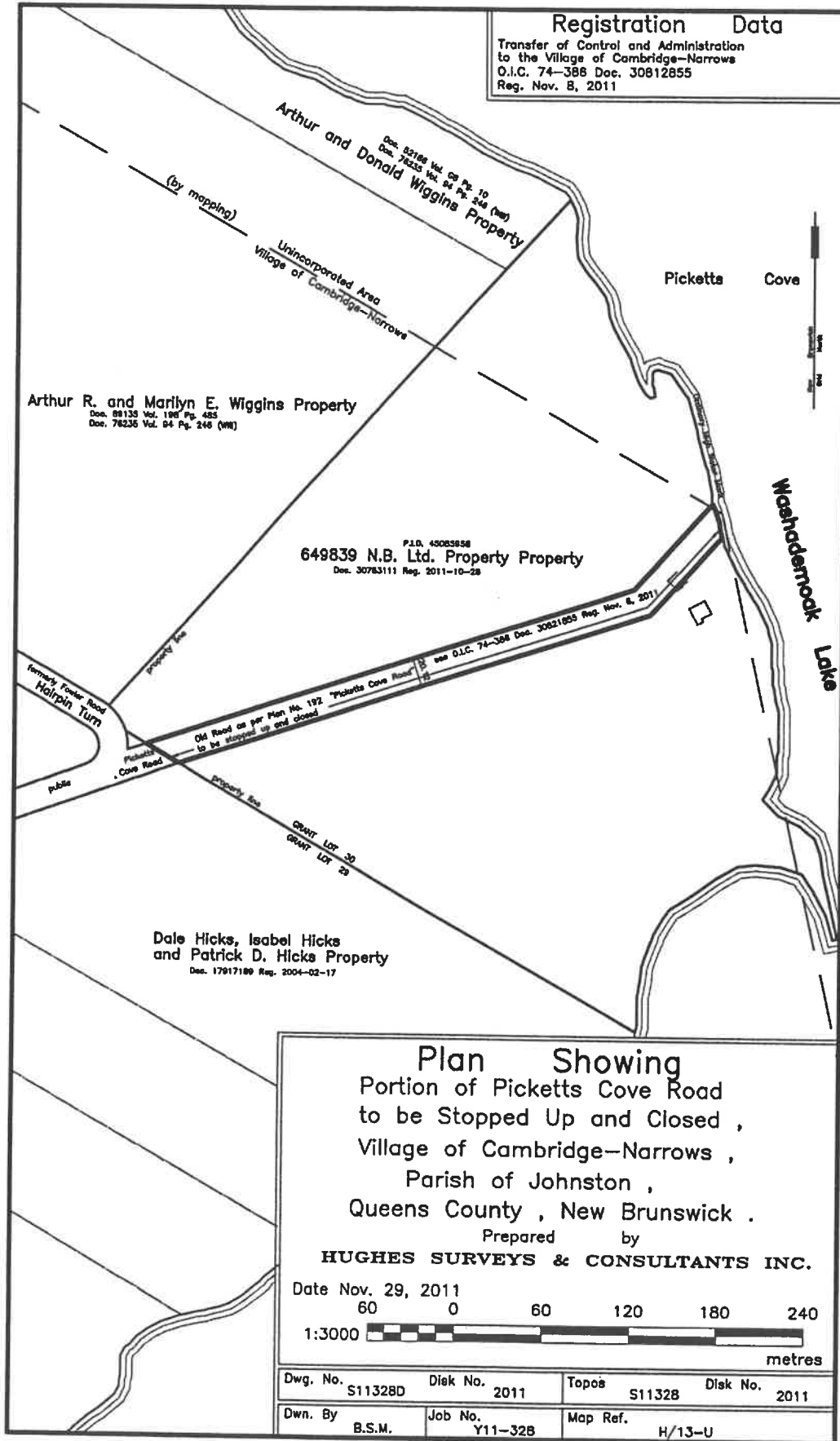

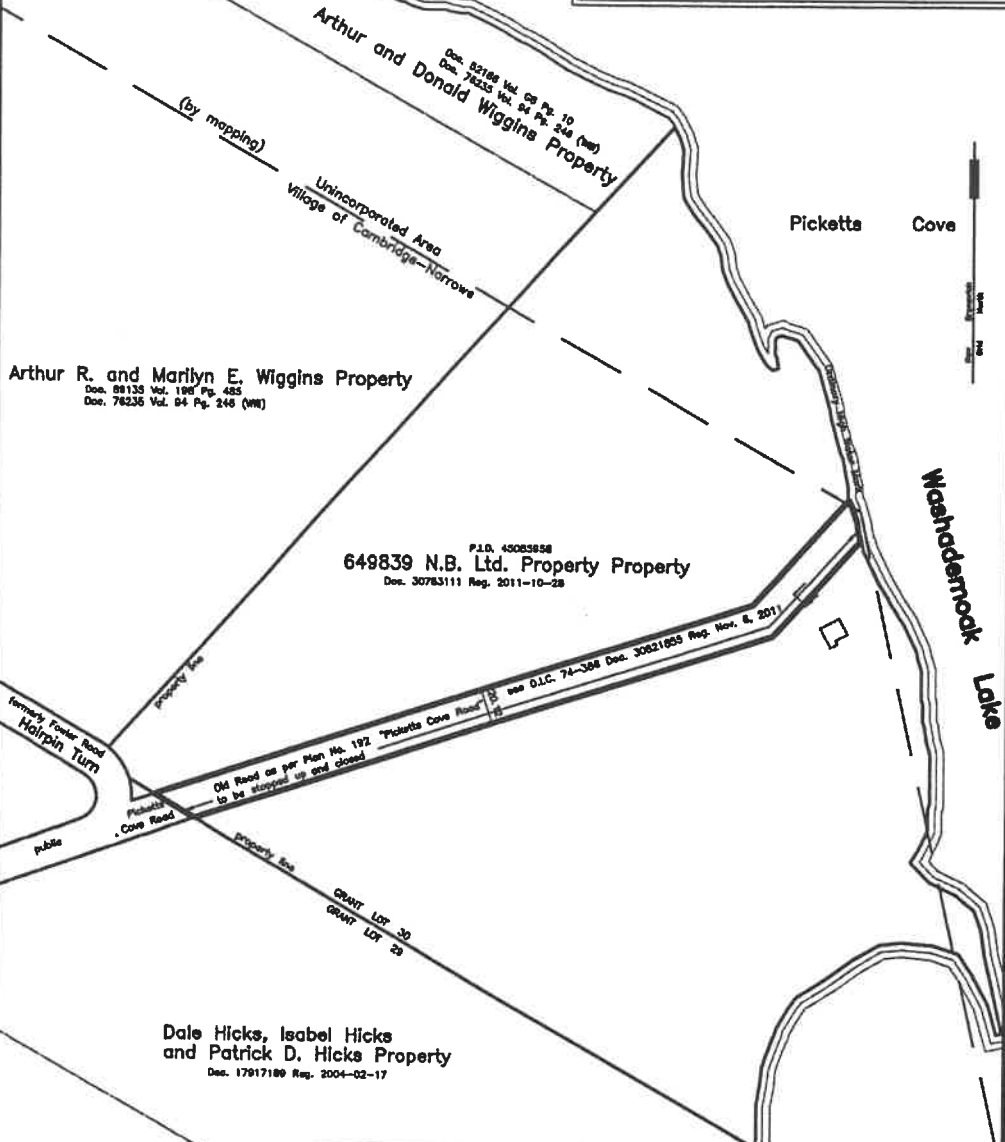
